respect of the Kerala State Indian System of Medicine Self- Financing
College Management Association (KISMA)- Order issued on 09.08.2019

ORDER

1. The President, Kerala State Indian System of Medicine Self Financing Management Association, hereinafter referred as KISMA, has submitted the Prospectus for taking admission under NRI quota for BAMS/BUMS/BSMS 2019-20 Courses in respect of the Member colleges under KISMA before the Admission Supervisory Committee, in short the ASC, for approval on 04.07.2019.
2. The Central Council of Indian Medicine, in short the CCIM, has issued a notification dated 7.12.2018 regarding the UG Regulation, wherein it is stated that

“The seat matrix for admission in Government, Government- aided Institutions and Private Institutions shall be fifteen per cent for the all India quota and eighty-five per cent for the States and Union territories quota.

The designated authority for counselling for all admissions to undergraduate course in all Ayurveda educational institutions in the States and Union territories including institutions established by the State Government, University, Deemed University, Trust, Society, Minority Institution, Corporation or Company shall be the respective State or Union territory in accordance with the relevant rules and regulations of the concerned State or Union territory Government, as the case may be.”

- 3.** In view of the above CCIM Regulation, the Government of Kerala has issued a G.O dated 12.06.2019, wherein the 15% seats reserved for all India quota in Ayush UG Courses (BAMS/BUMS/BSMS/BHMS) in the Government/Government aided institutions and Private institutions for the academic year 2019-20. But the Government of Kerala did not give any specification regarding the 85% Government quota.
- 4.** Later, the Government of Kerala has issued another G.O dated 16.07.2019, wherein it is stated that Self-financing Institutions, coming under the Ayush Department can admit 15% seat as NRI provided affiliation has been obtained from the Kerala University of Health Sciences, in short the KUHS, and CCIM, on the basis of KEAM Merit List and the criteria fixed by the ASC.
- 5.** The ASC has placed the draft prospectus before the Committee meeting held on 26.07.2019 and decided to issue specific directions

regarding admission procedure of NRI admission observing the triple test laid down by the Hon'ble Supreme Court of India.

6. Thereafter, the President of KISMA has requested the ASC that the KISMA will submit a revised prospectus according to the directions contained in the Government orders and he has also appeared before the Hon'ble Chairman on 02.08.2019 and requested for time to submit the revised prospectus till 09.08.2019. The Hon'ble Chairman allowed time to submit revised prospectus till 09.08.2019, as requested by the President, KISMA.
7. In the meanwhile the Government of Kerala has issued a modifying order dated 06.08.2019, wherein it is stated that the 15% NRI quota seats can be admitted on the basis of the NEET Merit list.
8. Accordingly, the Vice President, KISMA has submitted the revised prospectus along with the admission time schedule before the ASC for approval, as per the modifications made in the G.O dated 06.08.2019.
9. The Committee scrutinised the revised prospectus and found that there are 13 member colleges under KISMA for BAMS/BUMS/BSMS Courses. The ASC hereby provisionally approve the revised draft prospectus with the following directions and observations:-
 - (a) The KISMA shall submit the drat notification for inviting online application by the members colleges for the 15% NRI seats for approval of ASC. Other mode of applications will not be entertained and such applications will be rejected. The

notification approved by the ASC shall only be published the leading dailies and the Association website.

- (b)** The Member Colleges under KISMA have to provide online facilities for inviting online applications from the aspirants. The President, KISMA will issue strict directions to Member colleges to submit the model of the online application form before the ASC for approval on or before 13.08.2019.
- (c)** The Member Colleges under KISMA is hereby directed to keep all information regarding the admission procedure in the respective college website till approval of admission by the ASC.
- (d)** The Admission to the NRI quota shall strictly be as per the G.O (Ms) No. 243/14/H&FWD dated 06.08.2014 and the candidates should qualify in the NEET Entrance Examination.
- (e)** The member colleges shall strictly follow the directions contained in the Directives regarding the NRI admissions for Medical education issued by the ASC dated 28.07.2017 & 10.07.2019.
- (f)** The Member Colleges shall collect only the fees fixed by the FRC as per the order dated 09.07.2019. No Member Colleges are entitled to collect excess tuition fees from the candidates other than the tuition fee fixed by the FRC. In the case of special fees, the member colleges shall collect the fees fixed

by the committee during the academic year 2018-19 until the special fee is fixed by the FRC for the academic year 2019-20.

- (g)** The time schedule for admission submitted by the KISMA, is modified and stated as follows:-

- (h)** The approval of the ASC shall be obtained in every stage of admission. The Member Colleges under KISMA are hereby directed to follow the above directions strictly. If the member colleges fail to comply the above directions, appropriate action will be initiated by the ASC, as per the provisions of the Act.
- (i)** The President, KISMA is hereby directed to submit the modified prospectus before the ASC and the same alone shall be issued to the candidate and published in the website.

- 10.** Email this order to the President, KISMA and the Principal of the Member Colleges coming under KISMA.
