## **ASC 100/20/BAMS/BUMS/BSMS/KISMA**

**BAMS/BUMS/BSMS Admission 2020-21- Approval of draft prospectus for admitting 15% NRI quota seats in respect of the Kerala State Indian System of Medicine Self Financing College Management Association (KISMA)- Order issued 14.01.2021.**

### **PRESENT**

### **READ**

1. Lr. No. KISMA/ARC/001/2020 dated 15.12.2020 from the President, Kerala State Indian System of Medicine Self Financing College Management Association (KISMA), received in this office on 17.12.2020
2. This office Lr. No. ASC 100/20/BAMS/BUMS/BSMS/KISMA dated 01.01.2021
3. G.O (Rt) No.1/2021/AYUSH dated 01.01.2021 issued by the Ayush Department, Government of Kerala
4. Lr. No. KISMA/ARC/001/21 dated 04.01.2021 from the President, Kerala State Indian System of Medicine Self Financing College Management Association (KISMA).

### **ORDER**

1. The President, Kerala State Indian System of Medicine Self Financing College Management Association, in short the KISMA, through communication dated 15.12.2020 has submitted the draft prospectus for admitting 15% NRI quota seats in respect of the Ayurveda, Siddha, Unani, courses for the academic year 2020-21. But the KISMA has not submitted the letter of permission and the affiliation orders obtained from the competent authorities for conducting the above courses in respect of the member colleges for the academic year 2020-21.

2. The Committee scrutinised the documents submitted by the KISMA, it is also found that the KISMA has not produced the Government communication for permitting 15% seats under NRI quota to be filled up by the management.
3. Therefore, the Committee through communication dated 01.01.2021 has directed the president of KISMA to submit the modified prospectus along with the aforesaid documents.
4. Accordingly, the President of the KISMA through communication dated 04.01.2021 has submitted the modified prospectus along with the Government order dated 01.01.2021 before the Committee, in addition certain member colleges have also submitted the letter of permission from the CCIM as well as the affiliation order from the KUHS.
5. The Committee has gone through the Government order dated 01.01.2021, wherein it is stated that self-financing institutions coming under the Ayush Department can admit 15% seat under NRI quota provided affiliation has been obtained from the KUHS and CCIM.
6. The Committee scrutinised the revised prospectus and found that though there are Thirteen (13) member colleges under KISMA for BAMS/BUMS/BSMS Courses only Nine (9) Colleges have submitted the letter of permission and affiliation order from the competent authorities. But Three (3) colleges, viz, Santhigiri Siddha Medical College, P.N Panicker Souhruda Ayurveda Medical College and KMCT Ayurveda Medical College have neither submitted the letter of permission obtained from the CCIM nor the affiliation order obtained from the KUHS. Therefore, the President of KISMA is hereby directed to communicate this information to the member college and direct them to submit the aforesaid documents at the

earliest. The President of the KISMA also should inform the above colleges that the approval of the prospectus in respect of the above colleges are kept in abeyance till the aforesaid documents are produced before the Committee. However, the Committee hereby provisionally approve the prospectus submitted by the KISMA with the following directions and observations.

- i.** The application shall be invited by the Association/ Member Colleges only through online. No other mode of inviting application shall be entertained and liable to be rejected.
- ii.** The online application should contain the following information:-
  - The online application form should contain Auto generated Registration/ Application Number and auto generate date and time of submission of application.
  - The facility for uploading the photograph and signature of the candidate shall be provided.
  - The category/quota shall be clearly specified in the online application form. The category once selected shall not be changed under any circumstances.
  - The declaration of the candidate, as to the details provided in the application are true to the best of knowledge, should be included in the online application form.
  - The Directions dated 22.01.2020 & 22.10.2020 regarding the NRI admission issued by the Committee should be published in the Association/ College website.
  - The facility for taking print out of the application shall be provided to the candidate by the Homeopathic Medical College.

The President of KISMA/ the Principal of the member colleges shall ensure that the aforesaid information's are

included in the online application form.

- iii.** The Admission to the NRI quota shall strictly be as per the GO (Ms) No. 243/14/H&FWD dated 06.08.2014 and the directives issued by the Committee on various dates. The NRI candidates should qualify in the NEET Entrance Examination.
- iv.** The President of the KISMA is hereby directed to submit the draft notification for inviting online application for admitting 15% NRI quota before the committee **on or before 16.01.2021**, for approval. The approved notification shall only be published in the dailies and the electronic media.
- v.** The member colleges come under the KISMA shall not be entitled to retain the certificates and 1st year fee, if the student discontinues the course before the last date of closing of admission, prescribed by the competent authorities.
- vi.** The collection of liquidated damages shall be as per the final decision of the ASC/Court of Law. The colleges have no right to retain the Certificate and TC in case of student leaving the college, and the same shall be released, on the student with one of his/her Parents executing a bond undertaking to obey the order that may be passed by the Committee or the Court of Law.
- vii.** The President of KISMA is hereby directed to obtain prior approval from the committee at every stage of admission procedure.
- viii.** The President, KISMA has submitted the modified admission schedule before the committee for approval. The Committee scrutinised the same and found that the admission schedule required certain changes as stated below. The admission schedule

is hereby approved with the changes made by the committee.
