4. Considering the vacancy report submitted by the Ayurveda/Siddha/Unani Medical Colleges, the Committee hereby permit to conduct the spot admission for filling up the vacant seat with the following observation/directions.

- A.** The spot admission shall be conducted on 31.03.2021 and the notification about the conduct of the spot admission shall be published in the college website as well as the dailies.
 - B.** The number of vacant seats shall be mentioned in the dailies.
 - C.** The details regarding the venue, date and time of spot admission shall also be clearly mentioned in the notification.
 - D.** The list of candidates participated in the spot admission should clearly monitored and attendance sheets shall be maintained and forwarded to ASC soon after the completion of spot admission.
 - E.** The admission shall be made only based on the inter se merit of the participants.
 - F.** The member colleges are at liberty to contact the Committee for any instruction/clarification for conducting the Spot Admission.
 - G.** The Spot Admission should be transparent, Merit based, Non exploitative. If any irregularities/complaints received against the process of Spot Admission and found to be proved, the spot admission shall be cancelled without any further notice.
