ORDER

University vide paper read (1) above, invited applications for continuation of provisional affiliation for the Academic year 2021-22 from colleges for courses affiliated to the University. The Principal, Markaz Unani Medical College & Hospital, puthupadi, Kozhikode vide paper read (2) above has submitted application for the continuation of provisional affiliation for conducting UG (BUMS) course with an annual intake of 60 seats for the academic year 2021-22.

On verification of the applications it is found that the college had submitted necessary documents and remitted requisite fee for Continuation of Provisional Affiliation. Subsequently, University conducted inspection at the college to ascertain whether the college having required facilities to conduct BUMS course with an intake of 60 seats. The inspection commission vide paper read (3) above submitted the report and the same was scrutinized by the scrutiny committee in its meeting held on 28.01.2021. The scrutiny committee meeting held on 28.01.2021 after verification of the inspection report, has recommended to grant Continuation of Provisional Affiliation to the College for conducting BUMS course for the Academic year 2021-22 and suggested to inform the college for rectifying some of the deficiencies with in the permissible limit pointed out by the Inspection commission.

At the time of inspection conducted at Markaz Unani Medical College on 20.01.2021, it was found that a few faculties were physically present and the Principal submitted a declaration stating that the rest of the faculties were taking online classes. In order to verify the faculties of the college, the Scrutiny Committee conducted online verification of the faculty on 04.03.2021. Based on the minutes of the Scrutiny Committee, compliance report was sought from the college vide letter dated 12.03.2021. The compliance report submitted by the college dated 05.04.2021 was placed before the Scrutiny Committee meeting held on 16.04.2021 and the Scrutiny committee recommended to grant Continuation of Provisional Affiliation to Markaz Unani Medical College for conducting BUMS course for the Academic year 2021-22, since the shortcomings are with the permissible limit.

The National Commission for Indian System of Medicine, Ministry of AYUSH has granted conditional permission to Markaz Unani Medical College with 60 seats in UG (BUMS) course for the academic

session 2021-22 vide letter read 8th above.

The 66th Governing Council meeting held on 16.11.2021 vide decision read 7th paper above, has decided to grant Continuation of Provisional Affiliation to Markaz Unani Medical College & Hospital, Kozhikode for conducting BUMS course with an annual intake of 60 seats for the academic year 2021-22 based on the recommendations of the Scrutiny Committee and Letter of Permission from Ministry of AYUSH, Govt. of India.

In the above circumstances, sanction is hereby accorded to grant Continuation of Provisional Affiliation to Markaz Unani Medical College & Hospital, Puthupadi, Kozhikode-UM001 for conducting the following course with an annual intake of students mentioned against each during the academic year 2021-22 with the following conditions.

- 1 Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 2 In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 Affiliation granted is strictly provisional and only for the academic year 2021-22. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4 The College should remit annual administration fee fixed for UG/PG course for the academic year 2021-22
- 5 Admission to the next academic year shall be made only after obtaining prior permission from the University.


