ORDER

1. As per notification read (1) above, the university had invited applications for the Continuation of Provisional Affiliation for the academic year 2023-24. Accordingly, the Principal, Markaz Unani Medical College & Hospital, Kozhikode vide paper read (2) above had submitted application for the continuation of provisional affiliation, for conducting UG-BUMS course with an annual intake of 60 seats for the AY 2023-24 with necessary documents and remitted requisite fee.

2. Subsequently, the University carried out an inspection at the college to assess the facilities available for conducting UG-BUMS course with requested intake and the report of the inspection commission was placed before the scrutiny committee. The Scrutiny committee verified the inspection report and vide paper read (3) above pointed out one deficiency of higher faculty in the department of Kuliyaat at the college. Vide letter cited (4) above, the deficiencies were intimated to the college for rectification.

3. Consequently, the college has submitted a compliance report vide letter cited (5) above and the same was placed before the Scrutiny Committee in its meeting dated 10.08.2023. After





verification, the committee has recommended to grant conditional continuation of provisional affiliation to the Institute for conducting UG-BUMS course with requested intake for the AY 2023-24 on condition that the deficiency of 01 higher faculty in the department of Kuliyaat will be rectified shortly.

4. Considering the nearness of allotment process for the AY 2023-24 & recommendations of the Scrutiny Committee, the Hon'ble Vice Chancellor has accorded sanction to grant **Conditional** Continuation of Provisional Affiliation to Markaz Unani Medical College & Hospital, Kozhikode for conducting UG-BUMS course with an annual intake of 60 seats for the AY 2023-24, on receipt of Letter of Permission from Ministry of AYUSH & subject to the ratification of the Governing Council.

5. Now, the National Commission for Indian System of Medicine, Ministry of AYUSH, Govt. of India, New Delhi has granted conditional permission to Markaz Unani Medical College & Hospital, Kozhikode, Kerala for conducting UG (BUMS) course with 60 seats for the academic year 2023-2024, vide paper read (6) above.

6. In this circumstances, orders are hereby issued granting Conditional Continuation of Provisional Affiliation to Markaz Unani Medical College & Hospital, Kozhikode for conducting UG-BUMS course with an annual intake of 60 (sixty) seats for the academic year 2023-24, on condition that the deficiency of one higher faculty in the department of Kuliyaat will be rectified shortly. The College shall comply with the general conditions detailed below :-

i) The Continuation of Provisional Affiliation now granted by the university is subject to the ratification of Governing Council and confirmation of conditional Letter of Permission granted by NCISM vide letter cited (6) above. The college shall strictly comply to the conditions prescribed in the permission letter, within the time limit.

ii) Selection, admission and collection of fee shall be made only on the basis of rules and regulations of the University / Govt. of Kerala and on the basis of direction issued by the University from time to time, failing which the affiliation will be cancelled.

iii) In light of the direction of the Supreme Court of India in Writ petition (C) 656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

iv) Affiliation granted is strictly provisional and only for the Academic year 2023-24. The college has to apply for continuation of Provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of Approval from the apex bodies concerned.

v) The college shall remit annual administration fee fixed for UG course for the academic year 2023-24, if applicable.

vi) Admission to the next academic year shall be made only after obtaining prior permission from the University.
